# BIDS AND PROPOSALS

Wrought Iron Fence Repairs/ Repainting

Management provided the Board with bids from Cityscape, Inc 1<sup>st</sup> Street Painting to have the wrought iron throughout the community repaired and painted. UPON A MOTION DULY MADE, SECONDED AND UNANIMOUSLY CARRIED the Board approved the bid from Cityscape, Inc subject to the project not exceeding \$50,000.00. Cityscape will be requested to schedule the work during the spring months. This expenditure is to be paid from account 3318 Paint Reserve Fund.

**Shepard Hook Extensions for pool** 

Management provided bids from Humburg & Associates, Cityscape, Inc and Professional Craftsman, to install shepherd hook extensions on the wrought iron in the pool areas. UPON A MOTION DULY MADE, SECONDED AND UNANIMOUSLY CARRIED to approve Cityscape for this project, subject to the amount not exceeding \$10,000.00. Cityscape will be requested to schedule the work during the spring month. This expenditure is to be paid from account 3308 Fencing Reserve Fund.

Farmers Insurance Renewal

UPON A MOTION DULY MADE, SECONDED AND UNANIMOUSLY CARRIED, approve the renewal with Farmers Insurance for an annual premium of \$33,304.00, which includes the package policy, Umbrella and workers compensation.

Villa Park- Tree Trimming

Management obtained a bid from Villa Park Landscape to trim 136 trees in the community during the winter season. UPON A MOTION DULY MADE, SECONDED AND UNANIMOUSLY to approve the bid as for a total of \$6,440.00 to trim 136 trees throughout the community. Villa Park stated there is s 90 scheduling period for tree trimming.

Aquatrends bid to install controller for Title 22 and Monthly increase

Management provided a bid from Aquatrends to install chemical controllers on the pool and spa. UPON A MOTION DULY MADE, SECONDED AND UNANIMOUSLY CARRIED to deny the bid for \$9,627.78.
